# **VCCA Perimeter Signs Completed**

We are happy to distinguish our neighborhood as Vermont Commons by displaying the attractive signs David Hoyer, neighbor and VCCA Deed Restrictions Committee member, has diligently worked to create for us. The silhouette of a home framed by trees is rendered on the perimeter signs which, by the way, is our trademark for both the VCCA Newsletter and Website and will be posted at these five locations: Peden @ Driscoll; Vermont @ Driscoll; Vermont @ Huldy; Fairview @ Huldy; and Fairview @ Driscoll.

These sites were chosen by the Civic Association as being the entrances with the heaviest traffic flowing into our subdivision. The signs will let those passing along our streets know our residents are committed to maintaining a strong community and preventing crime through pride of homeownership and responsibility.

When asked how long the signs have been in the making, David Hoyer explained that roughly two years ago the plan was conceived by members under the leadership of then VCCA President, Mark Preston, who took steps to get the ball rolling. Since that time other VCCA officers, like Lance Hack, Nancy Higgs, and VCCA's current president, Jeanette Hix have encouraged David to see the project completed. After spending plenty of time and patience pursuing the City Permits for each of the five signs, selecting the best logo image, and working with Budget Signs on Shepherd to produce them, David is looking forward to having the signs erected in their designated places.

Our neighbor, David Hoyer, is hopeful the signs will contribute to a stronger sense of community, noting that people who have a sense of community typically take better care of their homes and better care of their neighbors in that community. Also, he feels the signs can provide more recognition to the name *Vermont Commons* while making us more identifiable on city and real estate maps, thereby enhancing our property values. Not a bad combination, Neighbor! Thanks, David, for all your work on our VCCA signs.

Key points from the presentation:

#### Gang Graffiti vs. Tagger Graffiti

#### **Gang Graffiti Characteristics**

- · Little artistic effort
- Uses gang signs and symbols
- Legible but un-styled
- One solid color
- Found in easy to reach places (walls, fences, dumpsters)
- Crossed or X'ed out
- Gang member names are small
- Gang name is prominent

This type of activity may appear insignificant, but it is usually the first sign of a gang's presence in a neighborhood, and depending on the markings, may indicate future violence or criminal activity. Whether it is gang or tagger graffiti, it should be cleaned as soon as possible. Property owners are responsible for abatement on their property, but can contact the City of Houston Neighborhood Protection Corps for assistance.

#### **Tagger Graffiti Characteristics**

- Obvious artistic effort and design
- Graphic
- Difficult to read, balloon or bubble shaped
- Multi-colored
- Found in hard to reach places (billboards, freeway signs, bridges, building tops)
- Tags are on top of other
- Tagger name is prominent

To report graffiti vandalism on public and/or private property, contact the City of Houston's 311 Helpline. Your request for assistance will be routed to the Houston Police Department's Neighborhood Protection Corps' Graffiti Abatement Program.

# Stop! Don't Put That in the Trash!

Computers and related components contain hazardous materials that can leach into a community's water supply. Cathode ray tubes (CRTs), circuit boards, batteries, and mercury switches contain hazardous materials, such as lead, mercury, cadmium and chromium. Residential electronic scrap items accepted by the City of Houston are monitors, televisions, printers, keyboards, mice, scanners, fax machines, telephone handsets, VCRs, CPUs, cellular phones without batteries and other small consumer electronics. There is a (5) piece maximum amount of electronic scrap per vehicle.

We have two convenient locations to dispose of environmentally unsafe household items in our area. Now, through a grant from the Houston-Galveston Area Council of Governments and the Texas Natural Resource Conservation Commission, the City has established the **Environmental Service Center** for the disposals of hazardous waste, **11500 South Post Oak**, **(713) 551-7355**, open Tue – Wed, 9am-3pm & the 2<sup>nd</sup> Sat of each month 9am-1pm. Paint, pesticides, batteries, smoke alarms, computers, televisions, most anything you shouldn't throw into the landfill can be brought here.

With the same grant from the Houston-Galveston Area Council of Governments, the Recycling Division has begun a "BOPA" program at the Consumer Recycling Center located at 5900 Westpark, (713) 551-7355, call for hours

from the landfill. These reclaimed materials from homes slated for demolition provide an invaluable resource to homeowners, builders, architects, designers, and artists. Since 2003 Historic Houston has relocated 30 historic houses to prevent their demolition and provided an alternative solution for Houston's low to moderate income housing needs.

Historic Houston, founded in 1998, is a 501 (c)(3) non-profit organization serving our community by reclaiming Houston's historic architectural resources and history through scholarly research, education, and advocacy of sustainable development. Since 2001 Historic Houston has sponsored multiple classes on Houston's historic neighborhoods conducted through the Rice School of Continuing Studies. The office and salvage warehouse of Historic Houston is open to the public Wednesday through Saturday and is located at 1307 W. Clay Street, just two blocks from Waugh Drive. It houses the Catherine Cage Burns Resource Center, which provides information on local and regional architecture and Houston neighborhoods.

As residents of an inner city neighborhood, we can help reduce the amount of demolition building materials taken to the landfill by contacting Historic Houston as older properties go up for sale. Given enough warning time to approach the owner, the home could possibly be relocated and or building materials such as windows, doors, and flooring could be salvaged by members of Historic Houston. of operation. The City of Houston now accepts "B"atteries, "O"il, "P"aint and "A"ntifreeze for recycling at the Center. The batteries accepted are cartype batteries (lead-acid); used oil up to 5 gallons and oil filters; latex paint only (sorry, no oil-based) up to ten 1-gallon cans and one 5-gallon can; and antifreeze up to 5 gallons. The latex paint accepted at the Center is recycled and used in the City's ongoing graffiti abatement program.

Additionally, the Center accepts up to 10 tires for disposal and electronic scrap items, too. While cleaning out the garage or under the sink, you wouldn't want to put any of these household hazardous waste items in the trash or down the sink, so load these items carefully into your car and take them to either of the locations listed previously. Glass food and drink bottles/jars are also recycled at Westpark, as well as at the 3602 Center Street Drop Off location near Heights Blvd, which is open 24/7. Good to know, since our curbside recycling service currently doesn't include glass of any kind.
