Recycle! Redeem! Reward! - VCCA April Meeting

The speaker at the VCCA April meeting will be Jorge U. Ungo. Jorge Ungo is the Recyclebank account manager for the City of Houston. Recyclebank (www.houstontx.gov/solidwaste/recyclebank.html) is a program that allows residents to earn points for participating in automated recycling using the 96gallon single-stream green cart rolled to the curb, bi-weekly, for collection.

The program is free to all residents with 96- Recycle gallon recycling carts, and is a great way to

reduce the amount of solid waste buried in Texas landfills. Participating residents earn points that can be used for discounts and deals at grocery stores, area restaurants, and services. Members can register for free on the Recyclebank website to begin earning points. Mr. Ungo will talk about how the program works and the benefits of participating, and will answer questions about the program.

Controlling the Homeless Cat Population: We Need Your Help

Spring is in the air, and we all can enjoy the beautiful flowers and budding trees. Unfortunately, none of us can enjoy kittens born to the free-roaming cats in our neighborhood. Now is the time to spay and neuter our Vermont Commons cats so we can avoid further escalation of the homeless cat population.

Your Vermont Commons Trap-Neuter-Release (TNR) Team has been busy trapping and fixing juveniles born to a stray mother cat on Huldy Street. Six



kittens have been trapped, fixed, and released in March alone. These cats were returned to the area where they were being fed after recovering from their spay/neuter. We are still working to trap at least two more kittens and the assumed pregnant (again) mother cat. (continued on page 2)

Spring Clean-Up: May 18th



The Origins of Earth Day: April 22

Most people know that Earth Day, celebrated on April 22, has something to do with the environment and clean-up activities. But how did it get started? Earth Day grew out of the activism and social upheaval of the 1960s—a time of civil rights demonstrations, war protests, and generational clashes. Added to this volatile mix was growing concern about ecological and environmental issues.

In the '60s, American cars guzzled \$0.30/gallon leaded gasoline through massive and inefficient V8 engines. Air pollution and lifeless waterways were commonly accepted as the cost of prosperity. Rachel Carson's seminal 1962 bestseller, *Silent Spring*, shocked the nation with its description of the devastating effects of pesticide use on wildlife. The title referred to a future without birds and discussed the destructive effects of toxic chemicals on the ecosystem, and ultimately on mankind.

Former US Senator and Governor Gaylord Nelson (Wisconsin) is widely recognized as the primary force behind Earth Day. Nelson believed the state of the environment "...was simply a non-issue in the politics of the country." He urged President Kennedy to promote environmental initiatives during Kennedy's 1963 national "conservation tour." In 1964, Congress passed the sweeping Wilderness Act, which protected more than 9 million acres of federal land from development.

Over the next six years, however, Nelson grew more and more frustrated by Washington's inability to make meaningful headway. His solution was to reach out to an increasingly alarmed public, proposing a national "teach-in" on environmental issues. And so, on April 22, 1970, some 20 million Americans took to the streets, parks, and auditoriums to demonstrate for a healthy, sustainable environment and policy reform. Senator Nelson directly credited the first "Earth Day" with persuading politicians that environmental legislation had a substantial and lasting constituency.

Significant legislation was passed in the wake of Earth Day, including the Clean Air Act Extension and laws to protect drinking water, wild lands, and the ocean. The Environmental Protection Agency was created in 1970 by President Nixon. Among the provisions of these bills was the requirement that autos use unleaded gasoline, achieve a minimum number of miles-per-gallon of gasoline, and be equipped with catalytic converters.

Earth Day is now observed in 175 countries. What should we do on Earth Day? Everyone can make a difference: walk more, ride less, buy less, grow some of your own food, recycle, plant a tree—participate, volunteer, get involved. As philosopher and educator Marshall McLuhan noted in 1964, "There are no passengers on Spaceship Earth. We are all crew."

Watch Out for Trees

Trees make our neighborhood more livable for us and for our feathered friends. Trees on most City of Houston right-of-ways are protected as described in sections V and VI of Chapter 33 of the City of Houston Code of Ordinances pertaining to the protection and preservation of trees and shrubs on city property. This includes trees on right-of-ways, medians, parks and other city property. A permit is required to remove any tree on city property or on a setback.

If you see any tree that may potentially be cut down on or near the right-of-way, call Dale Temple at 832-395-8459 or email him at dale.temple@houstontx.gov. (Keep in mind that the right-of-way typically extends farther from the street than the sidewalk.) Dale is an employee of the City of Houston and his job is to protect trees in Houston. He will make a site visit.
